My campaign team have discovered that contacting One Feather to request a mail in ballot is challenging. There is only a voice message that ultimately ends with you having to leave a voicemail to call you back. The voicemail states that they will get back to you by next day. However, we cannot be sure that they will call back in time for you to request a ballot.

It is very important for those who do not have access to a computer to request a mail in ballot package by email, that you contact One Feather by telephone.

YOU MUST REQUEST A MAIL IN BALLOT, THERE WILL NOT BE A BALLOT PACKAGE MAILED TO YOU WITHOUT A REQUEST. PLEASE MAKE YOUR REQUEST ASAP!

Please Note: If you want to ensure that you receive a mail in ballot package in time to cast your vote in the Peguis 2023 Chief and Council Election, be persistent and call every day until you speak to someone.

If you have requested a mail in ballot package via email, you should receive the package within four working days. If you have not, please contact One Feather to verify when they sent it.

Also, when you have received your mail in ballot package, please ensure you follow the instructions correctly.

To ensure that your mail in ballot is counted, you can ask a relative who is voting in person to take your sealed mail in ballot to the poll and give to the electoral officer or deputy electoral officer. You will have to fill out a form stating the information of the person you are delivering the ballot for or they may not accept the sealed ballot.

INFORMATION FOR THE ELECTOR:

THE BAND COUNCIL ELECTION OF THE PEGUIS FIRST NATION WILL BE HELD AT THE PEGUIS COMMUNITY HALL ON APRIL 6, 2023 FROM 9:00AM TO 8:00PM.

If you wish to vote by mail-in ballot, you must complete this form and send it to the Electoral Officer by mail, or e-mail. The information appears below.

You will not automatically be sent a mail-in ballot: you MUST request one.

YOU MUST ALSO INCLUDE A COPY OF PROOF OF IDENTITY, SUCH AS A COPY OF YOUR CERTIFICATE OF INDIAN STATUS, DRIVERS LICENSE, HEALTH CARD, OR ANOTHER DOCUMENT THAT PROVES YOUR IDENTITY. DO NOT PROVIDE THE ORIGINAL IDENTIFICATION.

If the Electoral Officer receives this request **before MARCH 31, 2023**, a mail-in ballot package will be sent to you at the address provided.

Please note that once you fill out this application and return it to the Electoral Officer, you will not be able to vote in person at any of the polling stations unless you bring your mail-in ballots to the polling station so that they may be voided. If you have lost your mail-in ballots, you must bring to the polling station a sworn affidavit stating that you have lost your mail-in ballots.
